What is the process



Assessed Processed Addressed

Set out the process

- Papers arrive by post, DX or are lodged in person
- Papers are assessed by Higher Executive Officers
- Papers are either returned with errors or are moved to the next checking phase which is at management level within the Probate Office
- Papers are then sent for final processing
- Grants are signed
- Grants are posted or collected

What is my role

- Order 79 Rule 4
- "the Probate Officer shall not allow probate or letters of administration to issue until all inquiries which he may see fit to institute have been answered to his or her satisfaction. The probate Officer is, notwithstanding, to afford as great facility for obtaining grants of probate or administration as is consistent with a due regard to the prevention of fraud".

What is my role

- Provide guidance and advice through the Courts Service website, through seminars and through one to one contact with the legal profession
- Ongoing engagement with the Irish Law Society

What is your role

- To act as professional advisors to Executors or Administrators
- To present applications which will lead to the issue of a Grant or Letters of Administration

What can the Probate Office do

- Rule changes
- Changes to fee structure
- Process changes
- Query policy



What can you do

- Ensure that competent and appropriately trained staff deal with probate applications
- Papers are checked before being sworn
- Papers are always checked by a solicitor before being submitted to the Probate Office
- A final check before actually submitting the papers to ensure that only the required documentation is submitted

Error types

- Too many papers/not enough papers
- No title
- Jurats
- Testamentary capacity
- Attestation clauses
- Bonds
- No death certificate
- Incorrect content
- Not following precedents



Implications

- We will publish details of the error rate
- We will lose resources cannot subsidise errors
- We will use technology to eliminate the problem
- We will restrict the use of post if errors continue at this rate
- We will identify the good the bad and the ugly
- We will target the best in class
- We will target the worst in class
- We may introduce certification
- We may move to the UK probate system
